## Executive **Summary**

Coin Kings is a coin prediction app designed to provide an engaging and frictionless experience. At its core, the game allows players to participate in predicting the performance/price of various coins over different time frames, without the need of actual trading. Players make picks competing for spots on leaderboards and the opportunity to win prizes and gain paying followers.

We plan to introduce a token, \$CKS, to support our ecosystem in Q2 2024, followed by a P2P marketplace and Market Analysis.

#### **Mission**

## GAME 1- BONKERS



## GAME 2- **SOL100**




Who will be the King of \$SOL? Simply choose which coin will do the best in the next 7 days!

### **TECHNOLOGY**

#### **User Interface and Experience**

Coin Kings prioritises a user-friendly interface, offering a seamless experience for both crypto-savvy individuals and newcomers. The interface integrates smoothly with popular Solana wallets, ensuring easy onboarding and interaction with the game's features.

#### Solana

Coin Kings is built on the Solana blockchain, renowned for its high throughput and low transaction costs. This choice offers a robust and scalable foundation for the platform, enabling rapid and cost-effective transactions, which is essential for a dynamic gaming environment. Solana's Proof of History (PoH) consensus mechanism also ensures a secure and decentralized operation, which is crucial for maintaining the integrity of the game and its transactions.

#### **Automated Digital Agreements**

The platform leverages Solana's advanced smart contract capabilities. These smart contracts govern some of the game's core mechanics, such as prediction outcomes, token transactions, and rewards distribution.

The smart contracts are designed to be transparent and tamper-proof, ensuring fair play and trust among users.

#### **\$CKS Token Integration**

The native \$CKS token, integral to the platform, is utilised for various in-game activities. These include entry into exclusive prediction events, receiving rewards, and participating in community governance. We will also operate a revenue share model for all token holders.

#### **Security and Compliance**

Security is a top priority, with regular compliance checks to safeguard the platform and our assets. Utilising Solana's robust security protocols, Coin Kings is committed to providing a safe and secure gaming environment. We will have the token independently audited before launch.

#### Scalability and Future Integration

The technology stack is designed for scalability, allowing for future integrations and upgrades, such as introducing new game features and token utilities.





## COIN KINGS REVENUE

#### **Generation of Revenue**

Coin Kings will generate revenue from taking a percentage of fees in the following streams:



**Follower fees:** Coin King shares all revenue from paid followers with the predictors on a sliding scale.



**Market fees:** Coin Kings takes 10% of all P2P activity on our marketplace.



**Revenue Share:** Our top traders will enjoy a percentage of revenue we earn.

#### **Total Token Supply and IDO Allocation**

The total supply of \$CKS tokens is set at a fixed number of 100 million. For the Initial DEX Offering (IDO), 15% of the total supply, which amounts to 15 million \$CKS tokens, is allocated.

#### **Pricing and Use of Funds**

The \$CKS tokens are priced at \$0.01 each for the IDO, aligning with the fundraising goal of \$150,000. The use of the raised funds is strategically divided among various critical areas: 14% is dedicated to development, ensuring robust game and platform creation; 20% is allocated for marketing and community engagement to build a strong user base; 66% goes towards providing DEX liquidity.

#### **Liquidity Pool and Team Allocation**

Tokens earmarked for creating a liquidity pool, essential for stabilising the market post-launch. The team allocation is set at 10% of the total token supply, vested over six months.

#### **Governance and Compliance**

\$CKS token holders are granted governance rights, with a voting system that gives each token one vote, fostering community involvement in decision-making. Additionally, continuous legal compliance across all operating jurisdictions is emphasized, particularly concerning securities law and anti-money laundering regulations.
